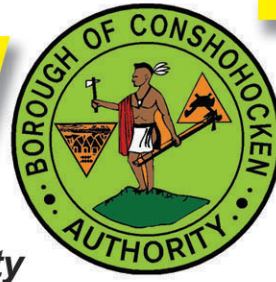

BCA Provides Education Opportunities to Community



Have you ever wondered what happens to the dirty water from your shower, laundry and toilet after it goes down the drain?

Since 2009, the Conshohocken Sewer Authority has been providing tours of the Wastewater Treatment Plant to a mix of undergrad and graduate Drexel University engineering students. Students use the Borough of Conshohocken Authority as a classroom to expand their knowledge on the disciplines of environmental engineering, biology and mechanical engineering.

For undergrads, this class in wastewater is the first of the series of discipline-specific engineering. For graduate students, it is

the beginning of expertise in the sub-discipline of water and wastewater. For a handful of PhD students, the class acts as a guided self-study for the advanced understanding.

In addition to college students, residents, local school students, clubs and Boy Scouts and Girl Scout troops are also invited to tour the facility to gain a better understanding of its operations.

The tour gives all participants a greater appreciation of the integral service that wastewater collection and treatment facilities provide in our daily lives. It is a "walking" biology lesson.

Tour Safety

Treatment plants are functioning industrial sites in operation 24 hours a day, seven days a week. Sturdy closed shoes and socks, as well as long pants are required for both your safety and comfort. No flip-flops, clogs, opened-toed shoes, shorts, or skirts. If you are not wearing the appropriate attire you may be prohibited from taking the tour.

Special Needs

While these tours involve quite a bit of walking, climbing of stairs and tight hallways, we can change the route to accommodate wheel chairs, canes and walkers. We have no facilities for, and cannot accommodate young children, infants or strollers.
