

# Coronavirus (Covid-19) Update

The novel coronavirus (Covid-19) is a new virus that causes respiratory illness in people and was declared a pandemic on March 11. Covid-19 is an national, international and Pennsylvania public health emergency. This is an on-going situation and updates will be on-going from governmental agencies.

# Safety and health precautions

- DO NOT flush paper towels, wipes, rags into the toilet-only toilet paper can go down your toilet. Those restricted items will cause sewer blockages and back-ups.
- Access to office and plant is curtailed-disinfection protocols were in place since March 9, 2020.
- Stay home as much as possible. If sick, quarantine yourself and those exposed.
- When you do need to go out, maintain adequate distance from others. Use disposable gloves (please throw in trashcan) or sanitizer. Wash your hands when you get home.
- Regularly sanitize common contact items like keys, phones, door handles, toilet handles, faucets, packages, gas pump handles, common surface.
- Wash your hands with hot water and soap for at least 20 seconds regularly! But always after being out.
- Don't share cloth towels. Use disposable, if possible.
- Cough and sneeze into your elbow.
- Avoid touching your eyes, nose, mouth and face.
- Check in on our elderly, isolated and compromised neighbors.
- No water shut offs are allowed during this national emergency.

# Symptoms of the virus

- Fever (over 100.4<sup>o</sup> F), Cough, Shortness of breath
- The symptoms may appear in as few as 2 days or as long as 14 days after exposure. Reported illnesses have ranged from people with little to no symptoms to people being severely ill and dying.

# How the virus is spread

- Through the air by coughing or sneezing.
- Close contact like kissing, touching, handshaking.
- Touching an object or surface with the virus on it.
- Occasionally, fecal contamination.

# **Truck an Upgrade for Authority**

The Authority acquired a needed update. A 2020 Peterbilt truck has been retro-fitted to serve as our Hydro-flushing vehicle. This truck is used to clean sewer mains and clear blockages. With a 1" diameter hose that is 600' long and a 1,500-gallon water tank, this vehicle can cover a lot of pipe! A saw can be attached to the hose to cut sewer roots. This will replace the old Hydro-flushing truck which was purchased new in 1993.
