New Processes Lower Costs

For the first time in more than 30 years, the Conshohocken Borough Authority's two plant digesters are operating at optimum performance levels. Operational problems had increased costs and projected capital Improvements expenses. Process changes were made to reduce said costs and have had a domino effect of positive results, ultimately saving the Authority and its ratepayers on operating costs and avoiding a \$3 million

premature expense.

The new interim executive director met with the operations manager and staff to explore a new approach to sludge handling. Steps taken include increasing air rates to digesters, more frequently decanting excess water from the digesters and the gravity thickener and reconfiguring the digesters from tandem operation to running in series.

Operational Processes Lessen Costs

The introduction and continual addition of seed sludge with healthy bacteria from another wastewater facility has dramatically improved the breakdown of biosolids.

One notable improvement is assigning Marty Higgins as the primary Belt Filter Press Operator to oversee the dewatering process. Marty was hired on Sept. 30, 2013, as a Utility Person. A Conshohocken resident, he appreciates his role serving the community. Marty received training from outside consultants to optimize the belt filter press operation and has improved the overall performance of the press. Marty improved the usual solids percentage of the dewatered sludge (cake) from 10 percent to 17 percent, seeing results as high as 21 percent. This means the Authority is hauling more cake and less water to the landfill, which reduces costs and increases efficiency.

Our capital plan was to replace the belt filter press with a screw-press technology, but it was determined that with the changes in operations, the current belt press operates correctly given properly maintained digesters and a trained, primary press operator.
