BCA Receives \$1.4M+ Grant

More than \$1.4 million in state grant funding will help the Borough of Conshohocken Authority increase efficiency and safety.

As part of the American Rescue Plan Act, Pennsylvania's Commonwealth Financing Authority announced in December that the Authority had been awarded \$1,454,471 as part of a larger grant aimed at funding projects for water supplies, sewer systems and stormwater management.

On Dec. 19, Pennsylvania State Repre-

sentative Greg Scott informed the Authority that we it had been approved to receive the grant funds from the H2O PA Program. The grant will be used to upgrade the plant's electrical sub-station, which is more than 30 years old. The sub-station receives electricity from two separate grids. In case one grid goes down, the sub-station switches over to the other grid and the plant stays energized without disruption to our treatment process. thority is to acquire, hold, construct, improve, maintain, operate, own, lease, in the capacity of either lessor or lessee, sewers, sewer systems or parts thereof, and sewage treatment works, including works for treatment and disposing of domestic sewage. One of his first projects was changing

the process in which we approach solids handling and our sludge inventory. He also led the charge to convert from using chlorine gas to liquid sodium hypochlorite, reducing one of the potentially most dangerous risks to our community.

Tips to Avoid Frozen Pipes This Winter

Leaky pipes that go unnoticed can easily become broken pipes, and in freezing temperatures even healthy pipes are vulnerable. Here are ways to prevent pipes from breaking and causing damage and costly repairs:

• Insulate exposed pipes and faucets outside and around your home, including those in unheated areas like basements, garages, attics or crawl-spaces.

• In severe cold, let cold water drip from faucets served by exposed pipes. Running a drip of water through the pipes helps prevent pipes from freezing because the temperature of the water is above freezing.

• If a pipe does break on your property, know where your water meter is and how to turn water off immediately to avoid further damage and water waste. Assess the damage immediately. Pipes can be thawed with a hair dryer.

• If you are taking a vacation or will be away for several days, turn off your water at the meter in case damage occurs or ask someone to watch your home in your absence.

• Outdoor hoses should be removed and stored. If available, shutoff outdoor water supply.
